VILLAGE OF ADDYSTON

ORDINANCE NO. 2020-04

ORDINANCE LIMITING THE WORK HOURS
OF PART-TIME MAINTENANCE WORKERS

WHEREAS, Coronavirus Disease 2019 (COVID-19) pandemic has adversely affected the projected revenues of the Village of Addyston; and

WHEREAS, Village Council passed an initial appropriation ordinance for the 2020 calendar year which must be modified to insure the Village's expenditures do not exceed revenues anticipated by the Village of Addyston; and

WHEREAS, the Village Council anticipates modifications to the appropriations for the calendar year 2020 and this ordinance shall address the first modification determined by Village Council due to the reduction in revenues for the Village of Addyston, now therefore

BE IT ORDAINED by the Council of the Village of Addyston, Ohio, as follows

Section 1. That the Village of Addyston Council limits the available hours for a part-time maintenance worker to 24 hours of work weekly for the position of part-time maintenance worker, with no more than two part-time maintenance workers per week, and the combined hours of any part-time maintenance workers shall not exceed a total of 48 hours per week.

Section 2. That the Village of Addyston Clerk shall not issue payment to any part-time maintenance worker for any hours worked in excess of 24 hours per week or a total of 48 hours per week for all part-time maintenance workers who work during a seven day period.

Section 3. That the Mayor or members of Council shall call a special council meeting and enact or pass a separate ordinance for the payment of any hours for any part-time maintenance worker that exceeds 24 hours per week or a total of 48 hours per week for all part-time maintenance workers who work during a seven day period.

Section 4. That Village Council hereby requests the Village Clerk to provide the Street Commissioner with a copy of this ordinance restricting work hours and pay for the position of part-time maintenance worker as set forth herein.

Section 5. This ordinance is hereby declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith. The reason for said emergency is the necessity for the Village of Addyston to insure that Village expenses do not exceed revenue and due to the reduction in Village income as the result of the Covid-19 virus.


