<u>Street Commissioner</u> – RJ Burton

He reported that the new overhead doors have been installed at the Fire House. He had spoken to Matt Geist of Southeastern Equipment it looks like it might be a little longer for the delivery of a backhoe as it's coming from another local government agency.

Acting Police Chief - Don McWhorter

He gave council the January 2021 statistics on citations, drug tracking cases, they had ten felony cases with a couple on the FBI Most Wanted List. He presented council with

a new program called DVERT on Domestic Violence he would like for the Addyston Police Department to be a part of the program.

A motion was made by Mr. Steve Dalton, seconded by Mrs. Jackson to have the Solicitor prepare a Resolution for council to approve the DVERT program, discussion, it's no cost to the village or police department, and Roll call vote: 6 Ayes motion adopted.

He asked council permission to send a letter to the Addyston residents concerning the donated vehicles, explaining about the donated items. A motion was made by Mr. Steve Dalton, seconded by Mr. Dan Dalton to mail out the letter to the residents, no discussion and Roll call vote: 6 Ayes motion adopted. He asked permission to purchase some safety equipment from the Community Police Initiative Fund; A safety vest for Officer Pate, a three used radar units, and camera units he felt if they could get all the equipment for \$1,000.00. A motion was made by Mr. Pillow, seconded by Mrs. Stafford to allow the purchase order to make the purchase of the equipment, no discussion and Roll call vote: 6 Ayes motion adopted.

Streets & Housing/Community Development - Chairman Dan Pillow

He reported in regards to the COVID Park Grant he needs the Village Clerk to complete a form that shows that none of the other Hamilton County COVID funds received have been or will be used on the Park Project. He mentioned that with the revisions the village submitted to HCCD and with the \$19,000 ODNR Reimbursement list there should be about \$6000 left to expend from the State Grant.

The drawing for the handicapped ramp that Mr. Pillow put together for the committee has been emailed to Thomas Bausch of the Lusk Group (same people who installed the post office ramp) for a Quote, if anyone else knows of another copy please let her know. Mrs. Jackson asked that when the weather permits that the Street crew paint the blue line on Main Street in support of the police.

Village Clerk Dozier stated that the municipal phones may need to be serviced and requested permission to contact Cincinnati Bell concerning the problems the employees are having. A motion was made by Mr. Steve Dalton, seconded by Mr. Dan Dalton to allow the Village Clerk to contact Cincinnati Bell, no discussion and Roll call vote: 6 Ayes motion adopted.

As there was nothing further to come before the Addyston Council a motion was made by Mr. Dan Dalton, seconded by Mr. Pillow to adjourn, no discussion and Roll call vote: 6 Ayes motion adopted.
