Mayor Lisa Mear called the special session of the Addyston village council to order at 6 PM, roll call of council found the following present; Mr. Dan Pillow, Ms. Jennifer Wiehe, Ms. Ann Pillow, Mr. Al Glick, Ms. Pam Jackson. Also present were Village Clerk Margaret Ann Dozier, Village Solicitor Robert G. Kelly, and Addyston Police Chief Eric Pennington. Ms. Jennifer Anderson was absent due to work. A motion was made by Mr. Pillow, seconded by Mr. Glick to accept the absence of Ms. Anderson, no discussion, and a Roll call vote: Five (5) Ayes motion carried.

Mayor Mear stated the purpose of the special meeting was to discuss the Summer Youth Work Program, Addyston Board of Public Affairs Trustee vacancy, and she requested that the Police issues be added to the meeting.

Mayor Mear stated that the Addyston Board of Public Affairs had voted to have William Nixon fill the vacant Trustee position and she agreed with the action by the Water Board. A motion was made by Mr. Pillow, seconded by Mr. Glick to confirm the Water Board action of appointing William Nixon to the vacant Water Trustee position, with no discussion and Roll call vote: Five (5) Ayes motion carried.

Mayor Mear called on Police Chief Pennington who stated that with the resignation of Lieutenant Dreyer he would like to recommend that Officer Ryan Welch be appointed full-time as a Full-time Officer, not as a Lieutenant just as a full-time officer. Chief Pennington's plan is to continue Officer Welch on a part-time schedule and then work him into a full-time schedule as a full-time. A motion was made by Mr. Pillow, seconded by Mr. Glick to have Solicitor Kelly prepare a Resolution for the appointment of Officer Ryan Welch as full-time, discussion Village Clerk asked if this meant Officer Welch would be filling the third full-time position vacated by Mike Dreyer, it was not adding another fourth fulltime position to the roster. Chief Pennington stated it was filling the third full-time position not adding another full-time position, no other discussion, and A Roll call vote: Five (5) Ayes motion carried.

Mayor Mear called on Laws and Contracts Chairman Jennifer Wiehe for a report on the Summer Youth Work Program. The Committee met on May 25, 2023, they discussed the application progress, pick up and deadline dates for all applications, established the parent/guardian meeting date, the start date of the program, the committee discussed the \$10,000 Budget for the program, and after much consideration agreed to recommend an \$8.00 hourly rate keeping in mind that if only a few kids apply, the council can revisit the hourly rate for a possible increase.
