Also present were Village Clerk Margaret Ann Dozier, Village Solicitor Robert G. Kelly. Department Heads include Addyston Police Chief Michael Martinsen and Police Officer Eric Weyda. Guests in audience Hamilton County Commissioner Denise Driehaus, Addyston resident Cathy Nixon Byess, Bill Noxon, Ray Adamson and Butch Runck. Mayor Lisa Mear was excused due to a scheduled vacation.

Village Clerk's Report – Margaret Ann Dozier

Minutes of the November 6, 2023, scheduled council meeting. Ms. Anderson made a motion, seconded by Ms. Jackson to adopt the minutes as printed, no discussion and a Roll call vote: Six (6) Ayes motion carried.

Pay Ordinance 2023-11 F for biweekly payroll paid on November 17, 2023, in the amount of \$13,345.16. A motion was made by Ms. Jackson, seconded by Mr. Glick, to approve the payments as made, no discussion and a Roll call vote: Six (6) Ayes motion adopted.

Pay Ordinance 2023 – 11 G for accounts payable in the amount of \$4,173.37. A motion was made by Ms. Pillow, seconded by Mr. Pillow to approve the expenditures, discussion from Mr. Glick on who the Lieutenant bars were for? Chief Martinsen reported for Eric Weyda, it the Chief's intention to make Eric Weyda lieutenant in the department because there needs to be a second in charge. Roll call vote: Six (6) Ayes motion carried. Ms. Jackson stated she felt the council should go into Executive Session sometime during the meeting to discuss personnel issues.

October 2023 UAN/PNC bank reconciliation

The starting balance all funds \$315,770.03, total receipts \$97,588.51 and \$128,188.59 in expenditures, \$2,500.89 in outstanding checks, no adjustments leaving a cash balance of \$285,169.95 balanced to the village pnc account. A motion was made by Ms. Anderson, seconded by Mr. Glick to adopt the October 2023 bank statement as presented by the Village Clerk, with no discussion and a Roll call vote: Six (6) Ayes motion carried.

Village Clerk Dozier reported that her request was part of the ongoing 2020=2021 state audit. Apparently, the village overall liability coverage isn't enough to satisfy the State. Therefore, she reached out to the village liability insurance company who emailed her a "individual performance bond" Quote for the three positions which hold money, since this matter is always listed in the state audits. The cost would be \$400.00 annually.

A motion was made by Mr. Pillow, seconded by Ms. Anderson to purchase the additional bonds, no discussion, and a Roll call vote: Six (6) Ayes motion carried. She requested that Solicitor Kelly bring a Resolution to this evening's council meeting for the council to consider purchasing the extra bond coverage.

Village Clerk Dozier stated that she had provided council with a year-to-date Revenue Status report, and year-to-date Appropriations report.

Village Clerk Dozier read an email from Police Officer Ryan Welch was resigned his position as police officer with the village of Addyston effective 11/24/2023. A motion was made by Ms. Anderson, seconded by Ms. Jackson to accept the resignation, no discussion, and a Roll call vote: Six (6) Ayes motion carried.

Mayor's Report -

Vice Mayor Pillow stated that Mayor Mear wants to remind everyone that the Hamilton County 513 bus will be here on December 13th between 10 a.m. and 3 p.m. Will likely need to reschedule the We Thrive for that day. Mayor Mear also was recommending Mr. Butch Runck to the Board of Appeals. A motion was made by Ms. Pillow, seconded by Ms. Wiehe to confirm the appointment of Mr. Runck to the Addyston Board of Appeals, with no discussion and a Roll call vote: Six (6) Ayes motion carried.

Vice Mayor Pillow called on the Guests in the audience. Hamilton County Commissioner Denise Driehaus who spoke to council on various happenings with Hamilton County. She also provided the council with a Menu of Opportunity of services offered by Hamilton County. She encouraged the council to reach out to the various departments. Addyston resident Cathy Nixon Byess came before the council with her continued concerns about the drug house next to her home. Solicitor Kelly made comments on her concern.

Vice Mayor Pillow called on Ms. Cathy Byess who wished to address the council. She wanted to know a status update on the nuisance property next to her house. Solicitor Kelly stated he would prepare an affidavit document for Ms. Byess and anyone else Ms. Byess asked to sign showing the many complaints against the occupants of 376 Three Rivers Parkway. Ms. Byess stated she was available anything.

He has sent a response to the Hamilton County Public Grants Action a request for along with the specs for the park shelter in the amount of \$25,000. He is pleased to announce that the village has received a \$91,000 grant from Ohio Natural Resources. He still needs to do some paperwork with Mrs. Fitch. Mr. Glick – he plans to meet with a company to look and get some cost of putting in the two new office spaces on the first floor.

Special Events - Pam Jackson, Chairman

She asked about setting up the Christmas with Santa Visit. A motion was made by Mr. Pillow, seconded by Mr. Glick to sponsor the Santa Visit on Saturday, December 16th, 2023, between 12:30 PM and 2:30 PM, discussion on the supplies from last year and Mr. Glick to contact Santa for his appearance that day, and a Roll call vote: Six (6) Ayes motion carried. Ms. Jackson brought up having the annual employees and elected officials' lunch with the public invited on Thursday, December 21st, between 11:30 AM-2:00 PM. A motion was made by Ms. Jackson, seconded by Mr. Glick to hold an emergency meeting to discuss police protection with Hamilton County, as soon as possible, and a Roll call vote: Six (6) Ayes motion carried. As there was nothing further to come before the Addyston council a motion was made by Ms. Jackson, seconded by Ms. Anderson to adjourn, with no discussion and a Roll call vote: Six (6) Ayes motion carried.
