AN ORDINANCE TO MAKE APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF ADDYSTON, OHIO DURING THE CALENDAR YEAR ENDING DECEMBER 31, 2023; SECOND AMENDMENT

WHEREAS, Council is required to make appropriations for the Village to continue the ordinary and businesslike operation of the Village for the year 2023;

WHEREAS, Council desires to amend the original temporary appropriations for the calendar year ending December 31, 2023, by this amendment; now therefore

BE IT ORDAINED by the Council of the Village of Addyston, State of Ohio:

SECTION 1. That to provide for the expenses and other expenditures of the Village of Addyston during the calendar year ending December 31, 2023, the following sums be and are hereby set aside and appropriated by individual account and by fund:

SECTION 3. That this ordinance is hereby declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety and general welfare and shall go into effect forthwith. The reason for said emergency is the necessity to proceed forthwith and continue the orderly and businesslike operation of the Village.
