ORDINANCE NO. 2022-25

AN ORDINANCE SETTING THE COMPENSATION  
OF CERTAIN VILLAGE EMPLOYEES  
AND DECLARING AN EMERGENCY

**WHEREAS**, Council has determined that it is appropriate to make adjustments in the rate of pay of certain Village employees commencing January 1, 2024; now therefore

**BE IT ORDAINED** by the Council of the Village of Addyston, State of Ohio:

**SECTION 1.** That the current rates of pay for the following specified positions shall be adjusted as follows:

| VILLAGE SECRETARY/CLERK OF COURTS    | \$19.28              |
| WATER BOARD CLERK                    | \$18.45              |
| POLICE CHIEF/ACTING POLICE CHIEF     | \$30.00              |
| POLICE LIEUTENANT                    | \$21.80              |
| POLICE SERGEANT                      | \$21.46              |
| POLICE CORPORAL                      | \$21.38              |
| POLICE OFFICER                       | \$25.00              |
| MAINTENANCE SUPERVISOR               | \$20.91              |
| MAINTENANCE WORKER                   | \$18.45              |
| WATER MAINTENANCE WORKER             | \$18.45              |
| CASUAL OR SEASONAL EMPLOYEE          | \$14.13              |
| STREET COMMISSIONER (monthly salary) | \$405.23             |
| WATER OPERATOR (monthly salary)      | \$658.82             |

**SECTION 2.** That the rates of pay set forth at Section 1, above, shall take effect on January 1, 2024.

**SECTION 3.** Employees of the Village as set forth herein who are required to work on any legal holiday as set forth in the Ohio Revised Code shall be compensated at the rate of time plus one half for all hours worked calculated on the rates of pay in Section 1 of this Ordinance.

**SECTION 4.** That this ordinance shall supersede and take precedence over any previously enacted ordinance or legislation pertaining to the rates of pay of the above-listed employees as provided in Section 1 of this ordinance.

**SECTION 5.** That, in addition to performing the regular duties of Chief of Police, the above-listed salary for the Chief of Police shall include the following: (a) attendance at meetings of the Village Council (no extra compensation shall be paid to the Chief of Police for such attendance), and (b) answering emergency calls when required (no extra compensation shall be paid to the Chief of Police for answering such calls).

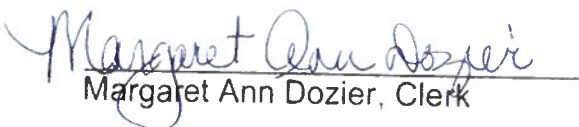
**SECTION 6.** That this ordinance is hereby declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety and general welfare and shall go into effect forthwith. The reason for said emergency is the necessity to provide adequate and realistic compensation to the Village employees and elected officials in order to foster and facilitate their loyalty and availability.
