The permittee, on behalf of itself, its agents, and any heirs, assigns, or successors, in exchange for the right to use a Addyston Village Park and/or equipment agrees to: Indemnify, defend and hold harmless the Village of Addyston, it's Mayor, Council, volunteers, agents and employees and all sponsors involved with the Village of Addyston Community Park from any and all liability, suits or claims for personal injury (including death), damage to real or personal property (including theft), and any other losses or complaints occurring during or as a result or participation in events held in Addyston Community Park, however, arising.

This agreement shall include - but not be limited to - holding all the parties harmless from all judgments and/or cost incurred in relation to any claims, disputes and suits, in addition to any attorneys' fees. I further acknowledge alcoholic beverages to any individual or participate in the sale of any alcoholic beverages on the grounds of the Addyston Community Park, except at special permitted events and/or areas.

I further acknowledge that the Village of Addyston assumes no responsibility for lost or stolen articles during any event held in the Addyston Community Park.

Park & Pavilion Rules

The Village of Addyston Park hours are from dawn to dusk.

The Village of Addyston reserves the right to close the park to the public at any time.

Addyston Community Park has 24 hour surveillance cameras.

Scheduling of sport activities must be done with the approval of the Village of Addyston. (special event permit)

Permit holders will have the right to use areas/ Pavilion that they have been assigned.

Areas/Pavilion not reserved will be available to the public on a first come, first-serve basis.

Parking is only permitted in the designated areas.

No parking in other areas unless specified and approved on application form.

No glass or alcoholic beverages of any kind allowed on park grounds.

Alcoholic beverages are allowed in the reserved Pavilion only.

No outside sales or solicitation can take place in the park.

Clean up any areas used and properly dispose of cool coals used in grills.

Use tape or push pins, not staples or nails when decorating shelter.

Please keep pets on a leash at all times while in the park.

Please clean up after you pet. There are doggy bag stations located throughout the park.

Speed limit 10 miles per hour.

Go-karts, Minibikes, are prohibited anywhere in the park.

All fees are due and payable at the time of reservation.

Notice of cancellation must be given no later than 60 days before the date of the function in order to receive a full refund; if the cancellation notice has given less than 60 days before the function, no refund will be given.

All NSF checks will incur a \$25 fee. The check amount plus the \$25 fee must be paid with cash or money order.

There will be no refund or pavilion rental fees due to cancellation because of inclement weather.
